REGULATIONS FOR RENTAL

1) Police formalities

Any person who has to stay at least one night on the campsite would have to produce his identify papers to the manager or his representative and carry out the police persons without their formalities. Young parents are not allowed. All accomodation renters may receive visitors for the day who come under the total responsibility of their hosts. They must comply with the campsite's regulations. It is forbidden for the renter to invite people to stay in the accommodation who are not included in the rental or to exceed the capacity of the accommodation in terms of the number of beds. Any person wishing to one of these accommodations automatically agrees to comply with these rules.

2) Taxes

Taxes will be paid to the Information Centre. The bill has to be paved at least on the day of departure between 9 a.m and 10 a.m. Another night will be added for delayed payments. The rented mobile home is available from 4 p.m on the arrival day and must be vacated by 10 a.m at least on departure day. In case of delay, an additional night will be charged. The security deposit amounts is CHF 100. In general, it will be returned to the renter upon departure. In the event of loss of or damage to items in the accommodation caused by the renter, the amount of the deposit will be reduced by the cost of replacing or repairing them. If the costs are higher than the deposit, a supplement will be claimed.

3) Behavior

The rented installations are non-smoking. Campers are required to avoid any noise and talks which may disturb their neighbours, and to turn down their acoustic appliances. Complete silence between 10 pm and 8 am is required.

4) Traffic and parking

Vehicles must be parked on the attributed place of park. One parking spot is available per mobile home. The access to the restaurant is forbidden for vehicles. The access to the mobile home is authorized on the day of arrival and departure for loading/unloading of luggage ONLY.

5) Keeping and look of the camp fittings

Everybody will have to respect the cleanliness and the hygiene of the campsite. Household waste must be packed in a plastic bag carrying the effigy of the "Camping Les 3 Lacs SA" and must be brought at the waste reception center. Containers are foreseen for the sorting of the glass, the fart, the paper, the batteries and the metal. The accomodation used during the stay will be kept in the state the camper found it when he arrived. Before the departure, a current situation (inventory of fixtures) will be made by an employee of the campsite. At the end of the rental period, the dishes must be cleaned, wiped and put away and the waste removed.

6) Security

a) Fire;

Open fires (wood, charcoal, etc.) are prohibited. Grilling is only allowed on grills designed for this purpose. In case of fire, let the camp manager being informed immediately. Fire extinguishers are an everybody's disposal. A first-aid kit is available at the Information Centre.

b) Theft;

Management is not responsible for the camper's things. Campers remain responsible for their own installation and have to let the manager being informed of any suspect presence. Campers are required to take care of their equipment.

7) Games

No noisy or disturbing game is allowed close to the accommodations but only of the official playground of the campsite. Parents will always have to watch over their children.

8) Swimming pool

The bracelet of control for the swimming pool must be worn at the wrist. You have to wear the bracelet when you are in the swimming pool or in the surrounding. Any loss of the bracelet must be announced at once in the Information Center. Your guests can't use the swimming pool. The rules for the use of the pool are posted in the pool area and must be followed.

9) Violations

In case one camper would disturb the stay of the other campers or would not respect the disposals of these rules and regulations, the manager or his representative could require the immediate departure. In case of penal infringement, the manager may call the Police. In case of disagreement, the french text is valid. Version 05,2022
